Sarah Pope Greene, Oak Knoll Farm

Sarah and her husband Adam Greene raise sheep and Sarah's company, San Juan Woolworks, makes knitting yarns and spinning fiber from the Oak Knoll flock She is also the manager of the San Juan Islands Food Hub, an interisland farmers' market.

Bruce Gregory, Mitchell Bay Farm

In addition to his local farm raising sheep, Asian pears, plums, apples and kiwis, Bruce is an Agricultural Resource Conservation Planner for the San Juan Islands Conservation District. He has volunteered with the USAID Farmer-to-Farmer Program, traveling as far as Tajikistan and Kyrgyzstan.

Zach Chan, New Hannah Farm

Zach thinks about the connections between food production, economics, climate change and social justice, and experiments with better farming methods, for example, using "no till" to help with carbon sequestration. He provides online ordering and convenient pickup for customers.

Around the League – State and National Issues The Supreme Court Allows Racial Profiling

On Sept. 15, the Supreme Court validated the use of racial and ethnic profiling in the United States. Using what is known as the emergency (or shadow) docket, the majority reversed a district court and 9th Circuit Court of Appeals holding that law enforcement agents could not detain people solely based on their race, the language they speak, their place of employment or where they gathered. The majority did not explain their decision, as happens often on the shadow docket. The three dissenting justices, on the other hand, issued a stinging indictment of the majority's position as well as Justice Brett Kavanaugh's feeble concurrence.

These facts show where many Latino families live, work, organize, and vote. But each household has its own story: a bus driver, a teacher, a small-business owner, or a college student. Closed Door for League Members Registering & Welcoming Newly Naturalized Citizens Prompts Concerns

Washington state and U.S. League leadership adamantly opposes the new federal ban announced
last month that prohibits nonprofit organizations from registering naturalized citizens to vote under
certain circumstances. The prohibition shuts the door for League members and raises questions
about whether new citizens are being provided the tools they need to register to vote.

The League Joins as a National Partner for Second No Kings – Saturday, October 18

League members from throughout Washington will turn out again for a No Kings mobilization day, this time with the League of Women Voters of the United States having joined as a national partner for the Oct. 18 event. The League believes that to protect and defend democracy, we must show up persistently - attending rallies and protests over and over again. In an email to all members last month, LWVUS President Dianna Wynn said the decision to join the sponsoring coalition for the second nationwide event was

intentionally made "to stand in solidarity with partners and stand up against hate and authoritarianism."

US Department of Justice wants WA Voter Records

In response to the US Department of Justice request to WA Secretary of State Hobbs to access a complete WA state voter database—including full names, addresses, birthdates and driver's license or partial Social Security numbers—LWVWA President Karen Crowley sent the Secretary of State a letter strongly opposing any release of personal voter information. Act Now: Access to Health Care at Risk

This week Seattle Children's Hospital announced that it may need to lay off as many as 154 workers this fall, due to the loss of federal funding from the budget cuts passed over the summer by Congress. In addition, 350 open positions will be eliminated effective Nov. 15. While most of the reductions are considered administrative positions, this could reduce timeliness of communications such as confirming coverage and answering the questions of patients and

their families. While this is a big impact for Seattle Children's Hospital, other hospitals around the state have been affected even more adversely. They do not have the vast

resources of Children's that can withstand some reductions. Fourteen rural hospitals across the state and 28 community clinics that provide a range of services from behavioral health care to dentistry are currently at risk of closure because of these federal budget reductions. And there will likely be more over time. When those hospitals are not available, Washingtonians must travel exorbitant distances to get critical care.

As has been widely reported, Congress is currently addressing a continuing resolution for the federal budget, and reductions in Medicaid and other health care funding have been pivotal in the Congressional budget debate. As of today, the US government is at risk of a shutdown with the current full-year continuing resolution (CR) for fiscal year (FY) 2025 set to expire on September 30.

TAKE ACTION: Contact Washington's senators and your congressional representative and ask them to hold firm on demanding that funding for health care be restored in the federal budget. Get the contact information.

The League of Women Voters has switched to a new member portal, ChapterSpot, for all Leagues across the country. By now, all members should have received an email to log in to the portal. If you haven't received an email, you can use this link to renew: https://portal.lwv.org/membership. You can pay online using a credit/debit card or by ACH (an electronic payment using the numbers on the bottom of a check). Once you have access to the portal, you will be able to update your own information, including contact information.

Anthony supporters, you need to separately submit dues and contributions. This can be done through the LWV Portal, which includes a separate donation button for local leagues, or by check to LWVSJ.
